
Homeowners are <u>always</u> welcome to attend the Open Session meetings to discuss general association issues.

ASSOCIATION DUMPSTERS



POOL FURNITURE

The pool furniture is available for all residents' use and enjoyment.

If you rearrange the tables and chairs, please be sure to return the pool furniture to its previous location prior to leaving the pool area.

Health

In order to abide by the OC

Dept.'s regulatory code, please

1) Keep pool furniture at least 3-feet away from the edge of the pool and spa

and 2) NEVER use the life-saver, unless for emergencies.

3) Clean up after yourself, dispose cigarette buds Residents in violation are subject to a fine, which we would like to avoid from occurring! Please notify your tenants.

OWNERS INSURANCE

Owners are required by the CC&Rs to obtain "owners insurance" to cover any damage caused to personal contents and unit interior surfaces. Please be reminded that the HOA is only responsible to maintain, repair, and restore the STRUCTURE of a unit, which excludes interior surfaces, personal contents, & plumbing and utility fixtures exclusively serving your unit.

Should damage occur to the interior of a unit, "owners insurance" protects owners by covering the loss of interior repairs and damage not covered by the association (e.g. paint, wallpaper, carpet, cabinetry, etc.). Please refer to your CC&Rs for more information.

All Homeowners are required to provide a copy of their current individual insurance to Interpacific Asset Management.

Homeowners are required to keep current insurance certificates on file with Interpacific at all times.
